

The **4PER1000** Strategic Plan 2050





<u>2020</u>

- The "4 per 1000" Strategic Plan 2050 was adopted by the Consortium of Members in June 2020 ;
- It sets a clear Vision and Mission for the next 28 years ;
- 24 Strategic Objectives with specific Goals and Targets were identified for 2030 and 2050, with a Baseline in 2020.





The **4PER1000** Strategic Plan 2050

<u>2021</u>

- During 2021, the 24 Strategic Objectives have been reviewed by 24 Working Groups called Task Forces, formed for the development of the Implementation Strategy;
- To ensure representativeness and objectivity, the Delphi study method was used. The collaborative platform also enabled a high level of participation ; More than 4,000 responses were received from 136 people involved in the 24 Task Forces, out of a total of 350 interested people ;
- The findings of this work were presented in Glasgow, on 10 November 2021, at the 5th Day of the Initiative







The 4PER1000 Strategic Plan 2050

<u>2022</u>

- In 2022, The Executive Secretariat reviewed 162 Activities resulting from the work of the Task Forces, organized within the 24 Strategic Objectives in 12 different Categories;
- In parallel, based on the proposals made by the Task Forces, each Strategic Objective has been reviewed : revision of the Title, Description, 2020 Baseline and 2030 & 2050 Targets ;
- This work has led to:
 - $\circ~$ Version 2 of the "4 per 1000" Strategic Plan 2050 ;
 - $\,\circ\,$ Version 1 of the "4 per 1000" Implementation Plan* ;



* The latter document was approved by the Consortium of Members in an electronic consultation in July & August 2022.






The **4PER1000** Implementation Plan



In parallel, the 24 Strategic Objectives were split into 2 families: the **Core Facilities** and the **Global Facilities**






The **4PER1000** Operational Framework



Partnerships and **Alliances** are formed by Partners, Members or supportive Friends of the "4 per 1000" Initiative.

The **Core Facilities** being led by the Executive Secretariat mainly through **Partnerships** with governmental and international organizations.

The **Global Facilities**, in the future, being led by **Alliances** of research organizations, NGOs and companies and **facilitated** by the **Executive Secretariat**.



- The 4 PER 1000 Strategic Plan adopted in June 2020 ;
- The 4 PER 1000 Operational Framework adopted end of 2021;
- The 4 PER1000 Strategic Plan Version 2 reviewed in 2022;
- The 4 PER1000 Implementation Plan Version 1 adopted end of Q2 2022;
- The inception of Coalitions : Partnerships and Alliances to be introduced as of early 2023.





Governance & Administration = Core Facility II



- The "4 per 1000" Initiative Bureau created in 2019, will pursue in 2023, with the support of all "Collèges" Representatives, the important task of developing the Vision and the "4 per 1000" Implementation Plan, while continuing to moderate the "Collèges";
- The STC Scientific and Technical Committee of the "4 per 1000" Initiative will pursue its work and mandate in 2023.

In 2023, as in previous years, the Executive Secretariat will continue to advocate intensively at the level of each country and each regional or international organisation for Soil Health, via soil carbon sequestration, to be an integral part of the NDCs (National Determined Contributions) and the resulting national programmes and/or plans.

Alliances will be a group of organizations which will be willing to gather around a specific Global Facility. Alliances will focus their expertise on Global Facilities, which include 11 Strategic Objectives from the "4 per 1000" Strategic Plan 2050.

- 2. Strategic Objective F2: Resource Mobilization
- Funder engagement
- In line with the work conducted in 2022 by the Executive Secretariat, the following process will be pushed further towards potential donors: identification, targeting, contact, convince to join the Initiative and call for funding. Other groups of potential funders will be explored while reaching the following groups:
 - Private Sector, Funding bodies, local and international Foundations, High Net Worth Individuals, People and Celebrities. In general, and whenever possible, it will be pursued that these potential donors become Partners or Members of the "4 per 1000" Initiative.

- 2. Strategic Objective F2: Resource Mobilization
- Seeking funding for the operating budget of the Executive Secretariat of the Initiative, for Core facilities (direct funding agreements)
 - Through Call for Funding towards the Partners, Members and Friends of the "4 per 1000" Initiative
 - Through the Promotion of the Book "Farmers have the Earth in their hands";
- Facilitating the engagement with public and private Donors to support Global Facilities: seeking funding for the Projects of the Coalitions (see Strategy Implementation Cycle SIC) (through earmarked funding via the FARM Foundation) ; Work on potential of Green Finance and Carbon Markets Initiatives

3. Strategic Objective F3: "4 per 1000" Dashboard

- The "4 per 1000" Dashboard will provide near real-time quantitative information on the "4 per 1000" Initiative's progress, considering Partner and Member measures.
- A large Coalition around that objective is needed in order to allow access to data that are important for such a Dashboard. A first concept note will be drafted during the year and potential partners will be approached to start the work in a short delay.
